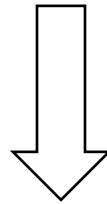

All of the above is not the responsibility of the Saco Yacht Club, it is the responsibility of the sponsor.

IF MORE APPLICATIONS ARE REQUESTED THAN THERE ARE AVAILABLE OPENINGS, APPLICATIONS WILL BE PICKED BY LOTTERY. The \$10 application fee is nonrefundable.

Probationary Requirements for New Members

**You Must:**

Attend (5) five meetings during your probationary period during. Meetings are the first Sunday of the month. (Exceptions are July, August and September when there are no meetings).  
This must be done during your first year of probation.

**You Must:**

Do a night watch yourself, No substitutes or rescheduling if you miss your watch!  
This night watch must be done during your first year of probation.

**You Must:**

Do (10) ten hours of surcharge work during your probationary year even if you do not have a pier or mooring assignment.  
You *can not* pay your surcharge during probation.  
This must be done during your first year of probation.

**Sponsor:**

Your sponsor is your mentor during your probation. If you have any questions ask your sponsor or any of the Club officers.

**Instructions to Sponsor and Candidate**

- 1. Application:** Only completed applications will be accepted. The membership committee will meet periodically to review submitted applications.
- 2. Applicant:** Must be 21 years of age
- 3. Applicant:** Is considered a probationary member for one (1) year and must attend five (5) scheduled Club regular meetings the first (1<sup>st</sup>) Sunday of each month.
- 4. Applicant:** Must complete ten (10) hours of surcharge work and serve a night watch during the Probationary period.
- 5. Applicant:** Cannot sponsor a new member during probationary period.
- 6. Sponsor:** The sponsor will be responsible for supporting the applicant in the successful completion of his probation responsibilities.
- 7. Interview:** The membership committee must interview the applicant and the sponsor.
- 8. Fees:** Application Fee: \$10 Initiation Fee: \$200 Dues \$100

Notes:

Dues: No matter what month you join the club, your dues for the following year is due Jan 1<sup>st</sup>, and no later than the first meeting in April.  
Any dues paid after the first meeting in January is subject to a late charge at the rate of five (5) dollars for each month.  
Dues will not be accepted after 12 noon at the April meeting. You will be dropped from the club membership if dues are not paid at the time of the April meeting. No exceptions.

After your probation : You may hire a substitute for night watch. Night watch is an annual member responsibility unless exempted by the Executive Committee.

After your probation: It is you benefit to attend Club Meetings to be informed of club business. Attendance is not mandatory.

After your probation: You are required to do (10) ten hours surcharge work for each year you maintain a permanent or temporary pier or mooring assignment, or store your boat on SYC property. The current rate for work performed is \$40 / hour. If you do not have a pier, mooring or boat storage, the work requirement does not apply.

You must read and sign this form. Applications will not be accepted without it.
